The Aransas Pass Independent School District Board of Trustees held a regular board meeting on April 11, 2022, in the boardroom at the district's Central Office located at 2300 McMullen Lane, Suite 600, Aransas Pass, Texas.

Superintendent's Report

Superintendent, Cara Cooke shared an update on the sports facilities and drainage improvements project, including guarantees from Texas Multi-Chem and Weaver & Jacobs regarding the adjustments to be completed to the baseball field after the completion of the baseball season. Mrs. Cooke also shared an update on the district's enrollment, attendance, and COVID-19 case numbers, the planning for the Summer X-STREAM adventure program, and an update on the district's calendar of upcoming events. The Board was asked to consider dates to schedule a team of 8 training.

Financial Reports

Information was shared with the Board regarding the accounts payable, budget status and investment, and tax collection reports for March 2022, and the bond finance and FEMA status reports for the month ended March 31, 2022.

Consent Agenda

Announce Board Training Hours

President, John Mullenax announced the continuing education hours of the Board of Trustees. President, John Mullenax stated that due to scheduling conflicts created by the COVID-19 pandemic, all trustees were unable to complete the Team of Eight Team Building training, however, this training will be scheduled in June 2022 as was previously discussed in this meeting. The majority of board members completed 90% of other required training. President, John Mullenax called for the pages as announced be attached to these meeting minutes, and the minutes be posted to the APISD website within 10 business days of the meeting and the posting be maintained until the deficient trustees meet the requirements.

Action Agenda

The proposed textbook selection committee made up of teachers to review and select textbooks for Health K-12 and Physical Education K-12 was provided for consideration. Secretary, Edel Deases moved to approve the textbook selection committee. Trustee, Olivia Hill seconded the motion. Motion passed.

The district-initiated policy change to policies DEC and FM LOCAL were provided for consideration. Trustee, Wanese Butler moved to approve the policy changes. Vice President, David Rector seconded the motion. Motion passed.

The plans for the Kieberger Wing Remodel were provided for consideration. Secretary, Edel Deases moved to approve the plans to amend scope of work including plumbing pre inspection for the remodel of one wing at Kieberger for district offices. Trustee, Olivia Hill seconded the motion. Motion passed.

Information relating to the recommended method of procurement, competitive sealed proposals, for the Kieberger wing remodel was provided for consideration. Secretary, Edel Deases moved to approve competitive sealed proposals (CSP) as the method of procurement for the Kieberger wing remodel project. Trustee, Olivia Hill seconded the motion. Motion passed.

Discussion

At this time, President, John Mullenax opened discussion for any topics to future meetings. Mr. Mullenax requested administration include on the next regular meeting agenda discussion and consideration of a plaque to be installed at the sports complex construction site. Mr. Mullenax also requested trustees consider topics for resolutions to bring submitted to the TASB Delegate Assembly, and the Board consider on the next regular meeting agenda nominating a primary and alternate delegate to attend the Delegate Assembly in September.
